NPC is one of the conditions which is quite prevalent in china, yet rarely encountered in the U.K. NPC has a very unique geographical distribution, where it is highly prevalent in southern parts of China. The aetiology is still unknown, yet there are papers suggesting a close correlation with epstein-Barr virus (EBV). Compared to 20 years ago, incidence of NPC has decreated. This may be attributed to the lifestyle alteration, such as changed smoking habits, decreated pickled food consumption, and introduction of western drets to Chinere culture. During my attachment in the ENT clinic, I managed to see a few cases of patients with NPC.
